



**PURCHASE OF STANDARD SCHOOL SUPPLIES AND EQUIPMENT**

**CERTIFICATION REGARDING PURCHASING COOPERATIVE  
FOR ELEMENTARY SCHOOL DISTRICTS WITH AVERAGE  
DAILY ATTENDANCE OF LESS THAN 2,500**

**Effective: July 1, 2024 – June 30, 2025**

This Certification is issued in accordance with Education Code section 38112 and Fresno County Superintendent of Schools (FCSS) Administrative Regulation 3300 (Purchase of Standard School Supplies and Equipment) and is effective during the period stated above.

The elementary school districts listed below are hereby certified to have membership in a purchasing cooperative consisting of Fresno County elementary school districts with an average daily attendance of less than 2,500 during the 2023-24 fiscal year.
